DETAILS OF WORK

On June 10, 1952, 7" casing was landed at 4402 feet and cemented with 300 sacks of cement. Rig down at 9:20 A.M., June 10, 1952. At 4:30 A.M., June 13, 1952, casing and water shut-off were tested at 1500 pounds pump pressure for 30 minutes. No drop in pressure. Thirty-four feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 1500 pounds for 30 minutes. No drop in pressure. Drilling operations were resumed.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
