**Plugging and Abandonment Procedure
Northeast Hogback Unit Well No. 46
Attachment "A"**

WELL DATA:

Location: 1765' FNL, 1980' FEL, Section 14, T30N, R16W
San Juan County, New Mexico

TD: 3308'
PBSD: 3267'

Surface Casing: 8-5/8", 32 ppf, J-55 set @ 102'. Cement w/ 60 sks cement.

Production Casing: 5-1/2", 14 ppf, J-55, set @ 3296'. Cement with 325 sks cement.

Perforations: 3104' - 3126', 3184' - 3216', 3224' - 3230', 3244' - 3250' w/ 4 JSPF

PROCEDURE:

1. Run in hole with tubing.
2. Mix and pump 27 sacks (31.9 cuft) cement. Spot balanced plug from 3250' - 2954'. Pull up to 2700' and reverse out tubing. WOC for 2 to 3 hours.
3. TIH and tag plug. (Plug must be at least 3004'.) TOH and lay down tubing.
4. Perforate squeeze hole at 152'.
5. Establish circulation down casing, through annulus and out bradenhead.
6. Mix and pump 56 sacks (66.1 cuft) cement down casing, through perforations, into annulus and out through bradenhead. Leave casing and annulus full of cement.
7. Cut off casing and install regulation dry hole marker.
8. Reclaim location as per BLM regulations.
