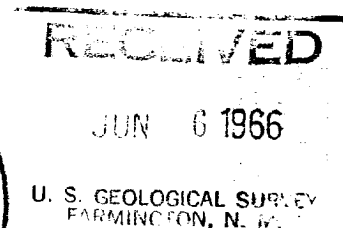

In reference to our Form 9-331 of April 13, 1966, a pulling unit was moved in on May 25, 1966 on the subject Northeast Hogback Unit No. 36. Pump and tubing were pulled, and 2-3/8" tubing was run with a packer set at 1634' and water injection into the Lower Gallup zone was commenced May 29, 1966 at a rate of 200 barrels per day at 480 psi.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
