DETAILS OF WORK

We propose to deepen with rotary tools from present T.D. of 4900' to the base of the Point Lookout Sand, shoot with Nitro for gas completion in both Cliffhouse and Point Lookout Sands. If after shot and cleanout if found necessary, 5-1/2" liner with perforations opposite the Cliffhouse and Point Lookout formations will be set from approximately 4691' to T.D.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
