DETAILS OF WORK

To check casing for possible leak, move in service unit, kill well, w/water, set retrievable bridge plug at approximately 3000', load hole w/water, locate and isolate hole in casing using retrievable plug. Break down or circulate through hole in casing w/water. If circulated through hole in casing, cement w/enough Incon cement to get returns to surface, if unable to circulate squeeze w/200 - 300 sacks, drill out cement, test casing to 1000 psi w/water, recover plug, re-run tubing.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
