DETAILS OF WORK

E. F. Elliott "C" Well No. 1. On December 20, 1958, spotted 200 gallons 15# mud clean out agent and perforated Pictured Cliffs with two shots per foot 2856-2886. Sand-water fracked with 30,000 gallons water and 50,000 pounds sand. Formation broke at 1475 pounds. Treating pressure 2000 pounds. Average injection rate 41 barrels per minute. 1-1/4" tubing landed at 2878'. Completed as shut-in Blanco-Pictured Cliffs Field Development gas well December 22, 1958. Preliminary test 1520 MCFD Pitot Tube Measurement after blowing 4 hours.
