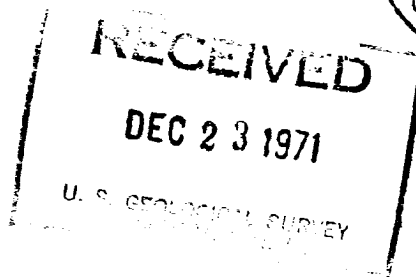
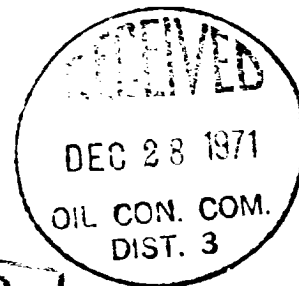

At a latter date the bridge plug could be drilled subject to approval.**

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, pursuant to applicable State law and regulations.
