In an effort to improve pressure maintenance performance in the Northeast Hogback Unit, we propose to convert Well No. 37 to a water injection well. Injection will be into the Lower Gullup zone perforations 1774-1894' with a packer to be set at approximately 1740'. Conversion is pursuant to New Mexico Oil Conservation Commission Order No. R-2026.
