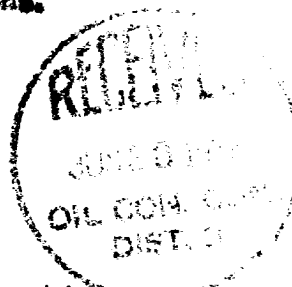

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

On June 19, 1959 well was spudded with rotary tools and drilled to a total depth of 222 feet. 8-5/8" casing was set at 214 feet and cemented with 160 sacks cement containing 2% calcium chloride. Cement was circulated. After waiting on cement, tested casing with 400 psi for thirty minutes with no indication of pressure drop. Reduced hole to 7-7/8" and resumed drilling operations.
