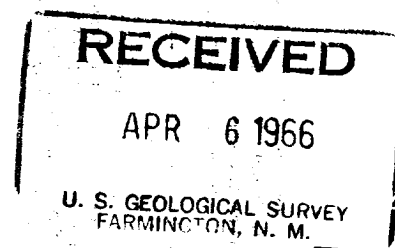
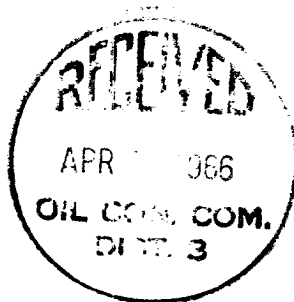

In accordance with New Mexico Oil Conservation Commission Order No. R-2026 authorizing Pan American to institute a pressure maintenance project in the Horseshoe Gallup Pool, we propose to convert Northeast Hogback Unit Well No. 32 to an injection well by using a packer for injection of water into lower perforations 1841-1874' in the Gallup formation. Conversion of well was previously proposed by our Form 9-331a of August 24, 1962 but was not done at that time.

Instructions
