7/23/85 MIRUSU. Kill well w/1% KCl. NDWH. NUBOP. Unseat pkr & pull two stds.

7/24/85 POOH w/1-1/2" tbg & pkr. PU & tally & RIH w/2-3/8" wrkstrg, Model F/A Latch Plug & Retrievalmatic Pkr. Set latch plug in a Model D pkr @6600'. PU & tested plug to 1500 psi. Held o.k. Isolated leak @4,090'. Dmpd 2 sxs sd on latch plug. Pulled pkr up & reset it at 3358'. Press tstd BS to 1500 psi. Left press on during sqz. Sqz'd leak w/100 sxs of Class B w/2% CaCl₂. Got a walking sqz w/75 sxs behind csg. Released pkr. Circ'd clean & PU 10 stds & reset pkr & re-press'd sqz to 1250 psi.

7/25/85 RIH with tubing and 3-7/8" bit. Tag the cement at 3870' Drilled out the cement squeeze. Pressure tested to 500 psi. Held o.k.

7/26/85 Tally in the hole with 1-1/2" tubing, seal assembly, and F nipple, hydrotesting to 2000 psi, LD one bad jt. Circulated the hole with packer fluid. Land seal assembly and the packer. NDBOP. NUWH. Pressure the BS to 500 psi. Held o.k. RDMOSU. Final tubing detail: 199 Jts 1-1/2" J-55 IJ, 6425.66' 5 Jts 1-1/2" J-55 EUE 162.42, a 2 and 3 ft. sub. Seal assembly landed at 6593.08.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
