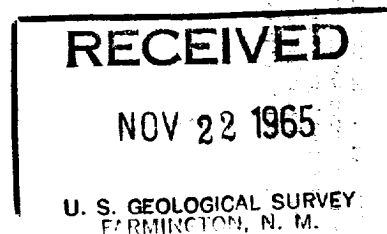

In order to increase production and improve the mechanical condition of this well it is intended to work it over as follows:

Pull the tubing of cut tubing off and clean out the open hole or drill a new side-tracked hole through the Mesa Verde pay.

Test the 7" casing and repair leaks by squeezing with cement or perforate at the base of the Ojo Alamo and block squeeze cement behind the 7" casing.

Set and cement 4 1/2" production casing, selectively perforate and sand-water fracture the Mesa Verde.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
