DETAILS OF WORK

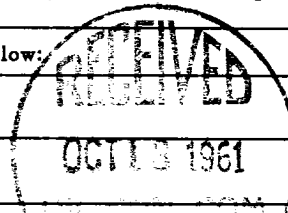

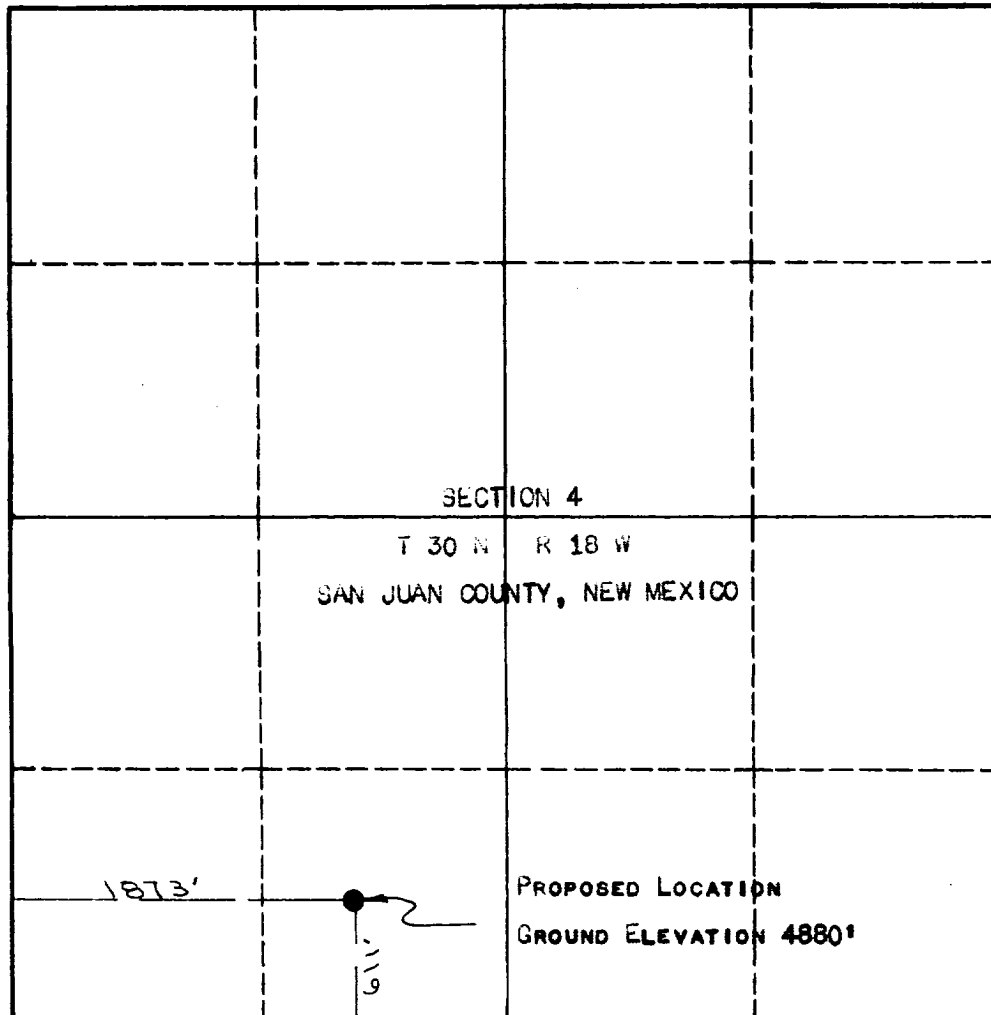
