7 " at 4529' with 300 sacks regular cement.

$\frac{1}{2}$  of Section 4 is dedicated to this well.

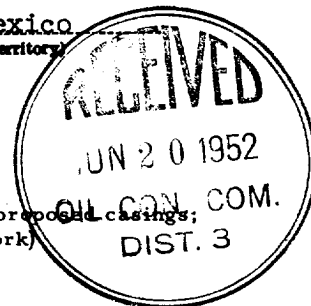
