

DETAILS OF WORK

- 10-31-57 TD 1755'. Perforated from 1590' to 1630' and from 1715' to 1750' with 4 shots per foot. Natural 3-hour bailing test showed estimated 5 gallons oil per hour. Sandfraced with 60,000 gallons crude oil and 85,000# sand.
- 11- 1-57 24-hour swabbing test showed 7 barrels oil per hour.
- 12- 1-57 ~~24-hour~~ 10-day pumping test showed 125 barrels of oil per day, which is believed to be pump capacity.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
