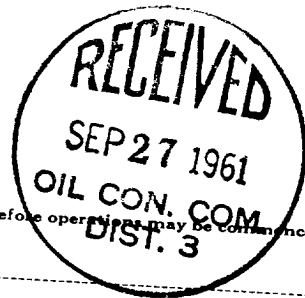
The elevation of the derrick floor above sea level is **6493** ft.

DETAILS OF WORK

It is intended to workover this well in the following manner:

1. Move in workover rig. Pull tubing.
2. Set bridge plug at about 5075'. Run McCullough Magnetic Survey.
3. Locate casing leaks and squeeze. Casing should be made to hold 2000 psi.
4. Drill bridge plug and clean out open hole.
5. Run 4 1/2" OD liner.
6. Perforate and fracture Mesa Verde formation.
7. Clean out and run tubing.
