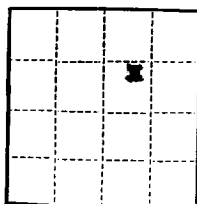

DETAILS OF WORK

Propose to drill to 200' and set 10-3/4" casing, cement to surface. Set 7-5/8" casing @ 3535', cement w/150 sz w/8% gal and 50 sz ment. Set 5-1/2" liner, approx. 2275' set @ 5710', cement w/200 sz ment.

Mesa Verde to be fractured through perforations using approximately 150,000 gals of water. Clean out to total depth, set tubing and complete well.

The 1/2 of Section 26, containing 320 acres, is dedicated to this well.

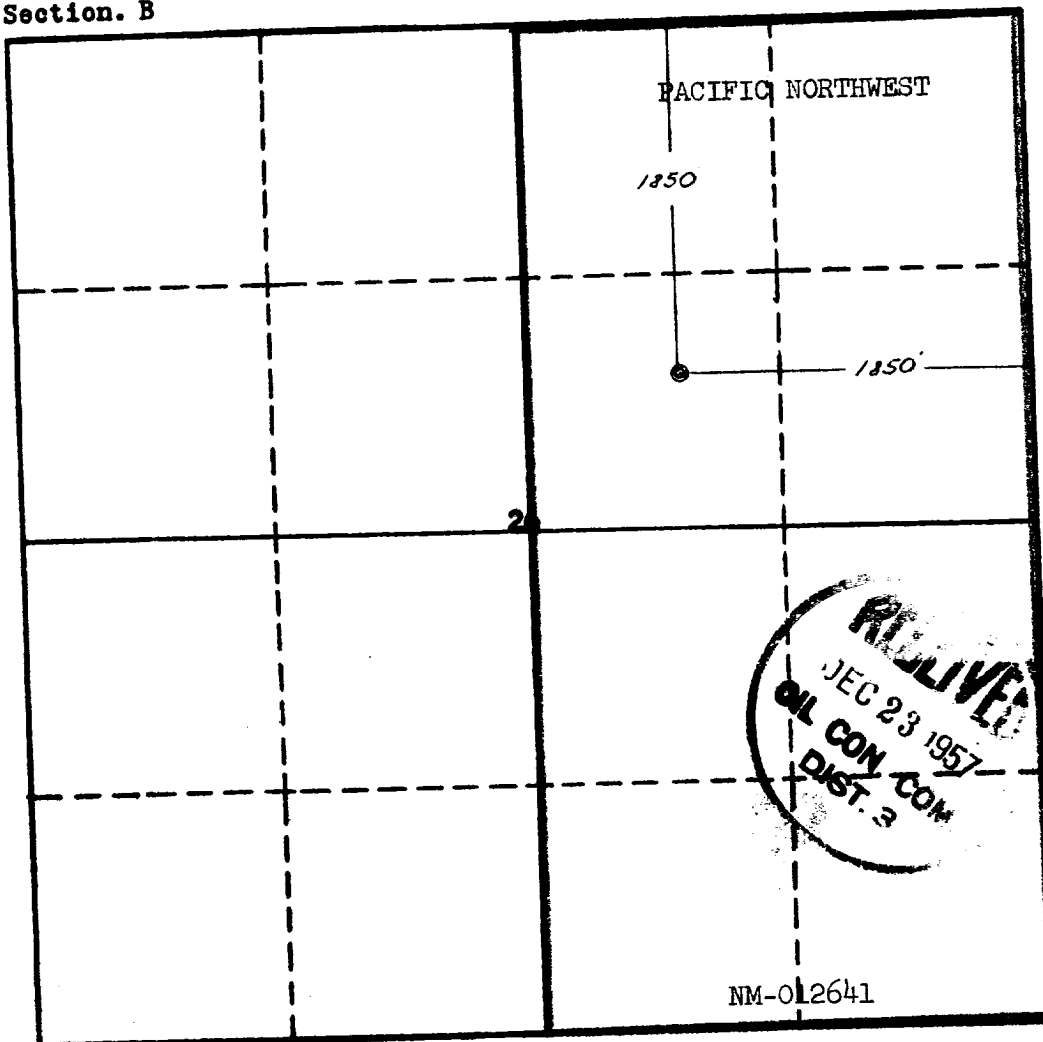
