 3. Pumped up. Cemented cement plug in ann. set windows at 5050' on June 3, 1962.
 4. Drilled 8" hole to 5245'. Drugged until pipe was left 6 collars in hole. Top of fish at 5165'.
 5. Run in jts. log, 4-5/8 8-35 log. and 1-5/8 jts. log 10,500 8-35 log. landed at 5209' A.M. w/Halliburton stage collar at 5245' A.M.
 6. Cemented first stage w/100 ex regular oil gel and 12% Gelsolite/ex, 12 Galms 9.
 7. Cemented second stage w/117 ex inc. cement w/100 gel. Cemented circulated to surface on June 21, 1962.
 8. Run cement bore log - no cement below 5245'. Surf. of hole 5245-5260 and squeezed w/75 ex regular 12 Galms 9. No pressure, ex-squeeze w/75 ex regular 12 Galms 9.
