Notice of Intent

Procedure to Sidetrack Well and Frac

RIH and set CIBP $\pm 20'$ below casing collar at $\pm 5260'$. Dump bail 5 sx cement on top of CIBP. Bottom of anchorstock will be 5' above casing collar at $\pm 5260'$. RIH with 6-1/4" bit. Air drill to 6200' TVD. RIH with 4-1/2", 11.6 lb/ft. N-80 casing to TD. Cement 4-1/2" casing with following slurry:

PREFLUSH: 20 bbls. Mud Flush
10 bbls. Fresh Water

LEAD CEMENT: 50 sx 65:35 POZ cement with 12% gel, 0.25 lb/sx Flocele + 2% CaCl_2 mixed at 12.0 ppg and 2.18 cf/sx.

TAIL CEMENT: 100 sx Class "B" cement + 0.25 lb/sx Flocele + 2% CaCl_2 mixed at 15.6 ppg and 1.18 cf/sx. (Note: Ensure that the TOC is in the 7" casing.)

RU electric line unit. Run GR-CCL-CBL-VDL from PBTD to 100' above TO or 5000' whichever is higher. (Note: We'll ensure TOC is at least 200' above 7" casing shoe.)

Perf for stress test-3-1/8" O.D. perforating gun, perforate intervals selected by D & P engineering. (all in the Mesaverde formation).

3-1/8" O.D. perforating gun-perforate the Mesa Verde formation at 4 spf (0.35" hole size) over intervals specified by D&P engineering.

Frac Well.

Land 2-3/8" 4.7# J-55 tubing at $\pm 100'$ above the top perforation.

Pressure test wellhead and RD & release rig. Put well on production.
