DETAILS OF WORK

The objective sands are the Cliff House and Point Lobos anticipated at approximately 530' and 565' respectively.

Proposed casing program: 200' 10-3/8" cemented to surface
315' 7-5/8" cemented with 150 sacks
365' 5-1/2" cemented with 200 sacks

We propose to drill with Rotary Tools employing mud through the Pictured Cliffs and gas drill to total depth. Estimated total depth 565'.

The well will be perforated and sand fraced to stimulate production.

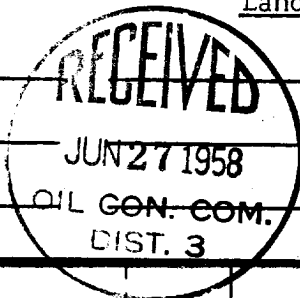

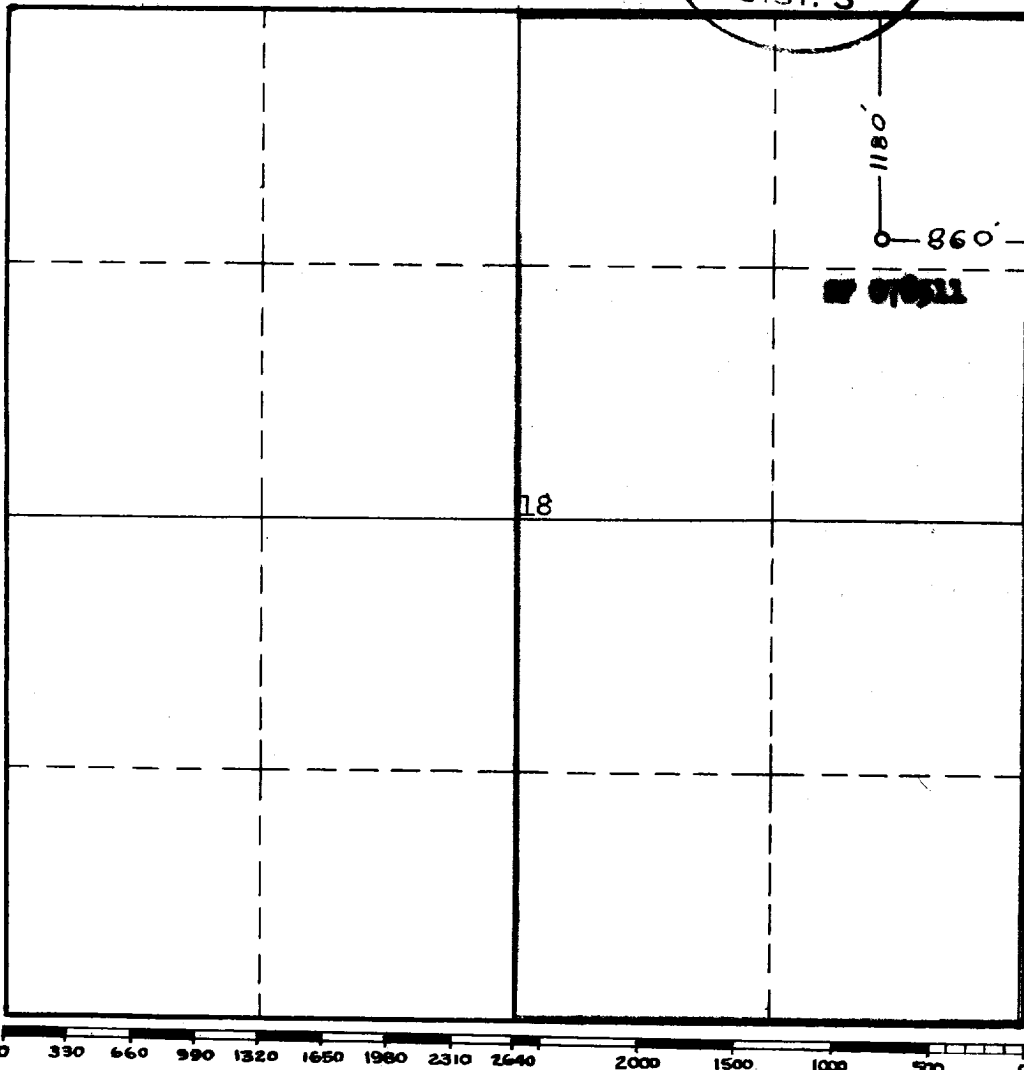
