### DETAILS OF WORK

It is intended to temporarily abandon this well in the following manner:

1. Move to workover rig.
2. Attempt to pack tubing, using blind slides if necessary.
- 2a. If tubing is setting out with cement at 100' below casing.
- 2b. If tubing is free, then pack and try down tubing.
3. Two cast iron bridge plug in bottom of intermediate casing and dump ball 10 sacks cement on plug as all the tubing is recovered from well.
4. If riser is left in open hole, then opt 100 sacks cement through tubing and attempt a bridgehead squeeze. Leave tubing in well above cement.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
