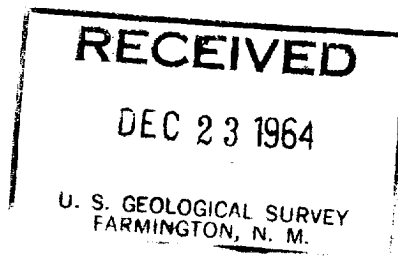

On 11-28-64 squeezed open hole (5220-5831') w/400 sacks Class "C" cement, 1/4 cu. ft. Strata-Crete 6"/sk., 2% gel, 1/8# Flocele/sk., followed by 100 sacks Class "A" cement. Pressured up to 2500#, reversed 11 bbls cement out. Pressured annulus to 1800#, Held C. K. Perf. 4 squeeze holes at 2700', set packer at 2592', pumped in 4 bbls/min at 500#. Cemented w/100 sacks regular cement, 2% calcium chloride. Cleared tool w/11 1/2 bbls, 500-800#. Pressured annulus w/1000#, released packer.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations; and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
