Swabbed hole dry. Tested for 2 hours with 500 lbs pressure. Pipe OK.

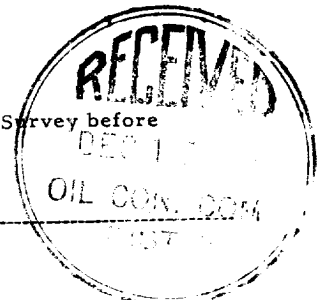
