The subject well failed the Bradenhead test conducted 6/24/02. Plans are to pull 1-1/4" tubing (may have to fish), find and isolate the casing leak and then remediate to regulation standards by squeezing with cement. Will preform a casing integrity test following remediation work. Work is scheduled to begin approx. 7/15/02.
