DETAILS OF WORK

Propose to drill to 200' and set 10-3/4" casing, cement to surface. Set 7-5/8" casing @ 3930', cement to 1000' above shoe using 8% gel w/50 sx neat on bottom. Set 5-1/2" liner @ 6130', cement w/150 sx reg. Test top of liner and Bradenhead squeeze w/50 sx reg if necessary.

Mesa Verde to be fractured thru perms using approx 150,00 gals water. Clean out to total depth, run tubing and complete well.

The E/2 of Section 4, containing 320.47 acres, is dedicated to this well.

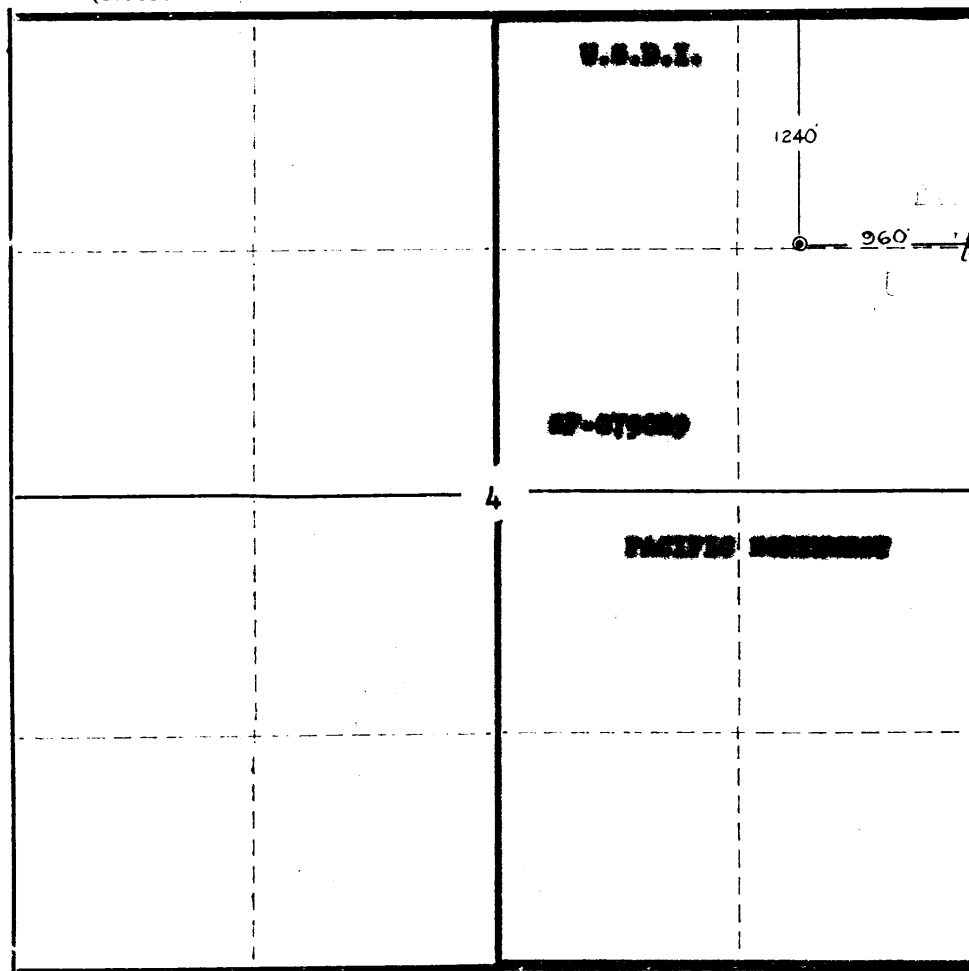
