

Total Depth 5945', interval treated 5747' - 5945'.

Set Baker Retainer at 5747' and treated Point Lockout formation with 9,300 gallons #2 diesel oil and 6,300# sand. Breakdown pressure 100# (By-passed retainer) Injection rate 253 gallons per minute. Flushed with 1,675 gallons oil. Gage before treatment 1,500 MCF. Gage after treatment 1,500 MCF. Packer failed to hold.
