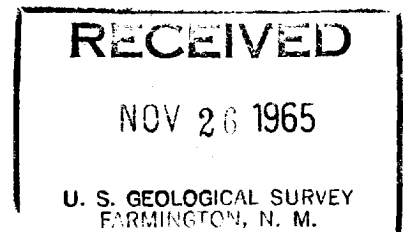

After drilling to 7,425 feet (RKB) ran 4-1/2" 10.5 and 11.6# J-55 casing to 7,425 feet. Cemented as follows: Stage 1: 225 sacks Class A 4% jel with 1% TIC. Stage 2: Stage collar @ 5308'. Cemented with 50 sacks Class A. 100 sacks poz mix with 4% jel and 1/2 cubic feet Stratacrete 6 per sack. Stage 3: Stage collar @ 2901'. Cemented with 20 sacks Class A, 40 sacks poz mix with 4% jel and 1/2 cubic feet per sack, Stratacrete 6.

Plug down at 1:50 P.M. on 11/16/65. Cut off casing and set slips. Rig released at 4:00 P.M. on 11/16/65.

Now awaiting completion rig.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
