Ran Welox GR-Density Log. Ran 1st jts. 3-1/2" 7# J-55 casing 10R, set at 3213. Cemented w/600 sx. cement. WOC. Temperature survey showed top of cement at 685'. Released rig 3/6/66. Installed wellhead. Now waiting on completion rig.

Instructions
