Spotted 400 gallons Dowell 888 acid from 6617-6006'. Perforated 6580-6564' with 6 jets per foot, (Dakota). Treated perforations with 50,000# 20/40 sand in 53,000 gallons water containing 1% J-98. Formation broke down 2900#. Average injection rate 27 BPM. Maximum treating pressure 3500 psi. Job complete 7:30 A.M., 11-2-61. Set cast iron bridge plug at 6535'.

Perforated 6450-6464' with 6 jets per foot. Tested bridge plug with 3300 psi, O.K. Treated perforations with 50,000# 20/40 sand in 56,700 gallons water containing 1% sacil and 1100# J-98. Formation broke down 2000 psi. Average injection rate 29 BPM. Maximum pressure 3500#. Job complete 12:45 P.M., 11-2-61.

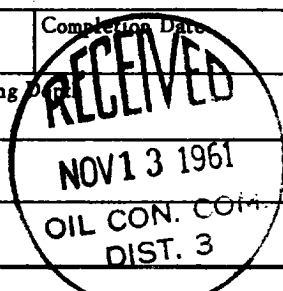
