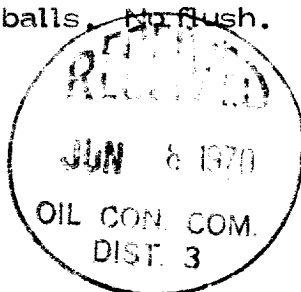

On 5-2-70 cut stuck tubing at 6277', pulled tubing.

On 5-3-70 Set cement retainer at 5091'. Squeezed open hole w/ 150 sacks of cement. Located holes in 7" casing (3031-49') (3080-97'). Set cement retainer at 2952', squeezed holes w/ 125 sacks of cement.

On 5-10-70 T.D. 6179'. Ran 190 joints 4 1/2", 10.5#, K=55 casing (6179' set at 6179' w/ 125 sacks of cement. W.O.C. 18 hours.

On 5-11-70 P.B.T.D. 6148'. Perf. 5718-30', 5742-54', 5788-94', 5826-32', 5946-52', 5974-36' w/ 18 SPZ. Frac w/ 70,000# 20/40 sand, 66,500 gal. water. Dropped 5 sets of 18 balls, flushed w/ 4000 gal. water. Set baffle and tested to 4000#. Perf. 5222-28', 5233-44', 5300-12', 5342-54' w/ 18 SPZ. Frac w/ 20,000# 20/40 sand, 20,980 gal. water, dropped 3 sets of 13 balls. No flush.
