-RIH with CMT RET, set @ 2517', Cmt SQ with 75 sxs Cl B W/2% CACL2, AIR 2 BPM, reverse out 1/4 BBLs CMT. RIH with TBG, 7" PKR, PSA set @ 1625', CMT perfs at (1900') with 75 sxs Cl B W/2% CACL2, AIR 2 BPM, Disp CMT 7 BBLs below PKR., circ thru perfs at 500' out of Bradenhead with 120 sx Cl B W/2% CACL2 CMT., DISP to 400'. Had good returns while cementing, Did not get cmt to surface only fresh water ahead of cmt.
