11/29/77 Road rig to location & rig up. Lay 90' of 2" from casing side. Blow well down.
11/30/77 Pump 100 bbl. water down tubing. Rig up & pull 2" (junk) tubing & lay down. pick up 70 jts. of 2 3/8" tubing from our float, run in hole. Spot 45 sacks cement plug on bottom @ 2178 to 2000'. Pull 2" tubing from well.
12/1/77 Run tubing in hole, tag cement @ 1982'. Cut surface pipe off 3" below ground level. Rig up 5 1/2" casing tools and work pipe.
12/3/77 Run casing shot to 965', shot pipe. Work pipe loose, pull & lay down 32 jts. 5 1/2" bad pitted pipe. Rig up 2" tools, ran 2 3/8" tubing in hole to 875 ft. Mix and spot 45 sacks cement. Pull 2' out of hole. Drain up pump and lines.
12/5/77 Went in hole with 2" tubing, tag cement plug @ 742'. Pull tubing up hole, mix & spot 40 sacks cement plug @ 200'. Mix 20 sacks cement & pump in @ 30 ft. inside 8 5/8" casing. Set dry hole marker. Rig down, drain up all pumps. Road rig to yard.
