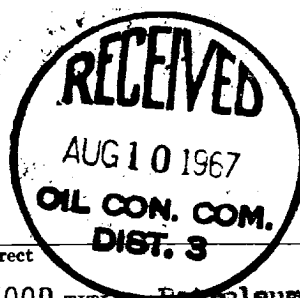

On 7-29-67 T. D. 3115'. Ran 99 joints 2 7/8", 6.4#, J-55 casing (3105') set at 3115' w/170 sacks cement. W.O.C. until completion.

On 8-2-67 P.B.T.D. 3095', tested casing to 4000' O. K. Perf. Pictured Cliffs 2984-96', 3006-14' w/24 SP2. Frac w/30,000# 10/20 sand, 33,400 gal. water. Max. pr. 4000#, BDP 1200#, tr. pr. 2800-3100-3400#. I.R. 23.4 BPM. Dropped 1 set of 26 balls, flushed w/860 gallons of water. ISIP 200#, 30 Min. -0-.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
