Instructions

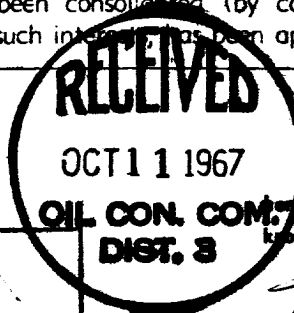

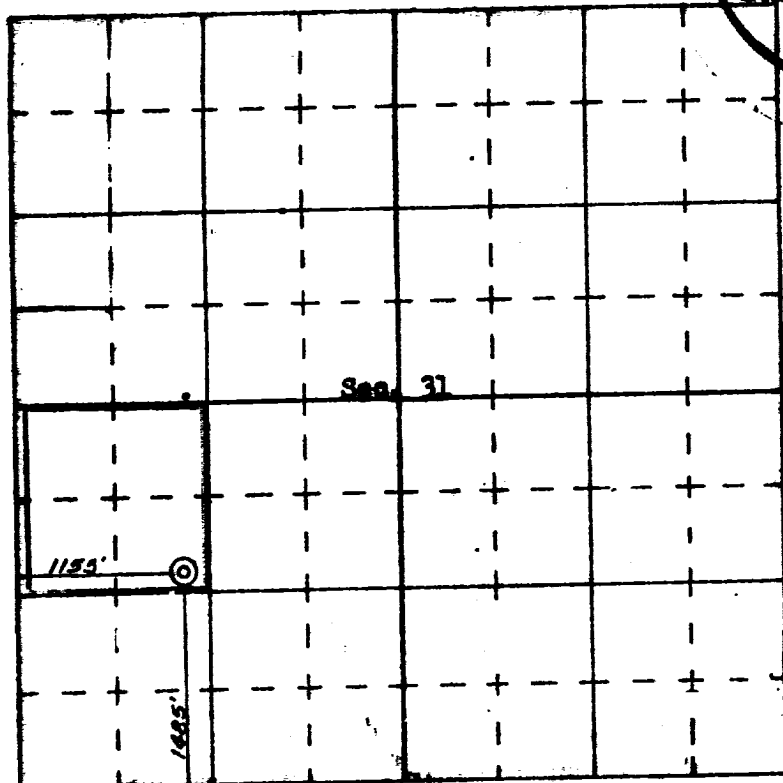
