Spudded 9:00 A.M., 1/28/ 68. Drilled 8 3/4" hole to 10', set 7" surface pipe cemented with 2 sx. A 5 5/8" hole was then drilled to 1061' and water encountered. The well was then plugged and abandoned by spotting a 13 cu. ft. plug from 1061' - 984', 16.5 cu. ft. 540' - 445' and 8 cu. ft. 50' to surface. Well P C 1/29/68.
