Cross Timbers Operating Co. has spudded the above mentioned well @ 8:30 a.m. (MDT) on Oct. 23, 2000.

Cross Timbers set 5 jts of new 7", 20#, J-55 STC casing at 228' KB (KB is 4' above ground level). The surface casing was cemented with 75 sx of Type III cement and was mixed at 14.6 ppg & 1.39 cuft/sx yield. 8 bbls of cement was circulated to surface. The rig waited 13 hrs on the cement before installing the BOP's and before drilling ahead.
