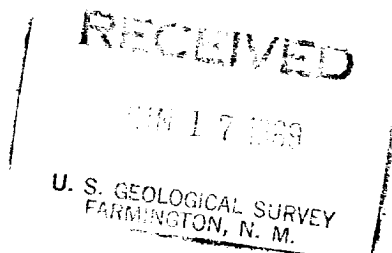
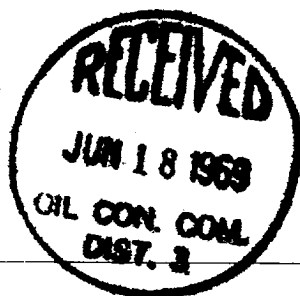

On 5-15-69 spudded well, drilled surface hole.

On 5-16-69 ran 7 joints 8 5/8", 24#, K-55 casing (219') set at ground level w/165 sacks of cement circulated to surface. W.O.C. 12 hours, held 600#/30 Min.

On 5-26-69 T.D. 2588', ran 83 joints 2 7/8", 6.4#, J-55 casing (2577') set at 2588' w/225 sacks of cement. W.O.C. until completion.

On 6-13-69 P.B.T.D. 2578', tested casing to 4000# O. K. Perf. Pictured Cliffs 2507-21' w/24 holes, 2536-44' w/23 holes. Broke perf. down w/2800#, pumped 200 gal. 15% HCL into perfs. Frac w/30,000# 10/20 sand, 28,000 gal. water. Max. pr. 4000#, avg. tr. pr. 2800#, I.R. 22 BHM. Dropped 1 set of 24 balls, flushed w/630 gal. water. ISIP 500#, 5 Min. 450#, 15 Min. 400#, 30 Min. 300#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
