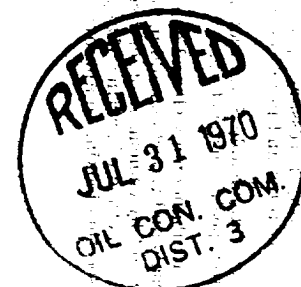

30004 The 4-1/2" casing was set at 7926' with the DV tool at 5790'. The first stage was cemented with 500 sacks Type "C" with 6% Gel and 2 pounds medium Tuf Plug followed by 100 sacks Type "C" Neat. Cemented the second stage with 100 sacks Type "C" with 6% Gel and 2 pounds medium Tuf Plug followed by 50 sacks Type "C" Neat.

Instructions
