The 7-5/8" intermediate casing was set at 3599' and cemented with 600 sacks of Type "C" cement with 6% Cel and 2 pounds Medium Tuf Plug per sack and followed by 50 sacks Neat "C" cement. Waited on cement to set 12 hours. Tested BOP (blind ram) and casing to 2000 pounds and OK.

Instructions
