Ran 2 3/8' tubing to bottom, set plug #1 from 901' to 400 (50 sks.). Waited 15 minutes, mixed more cement, set plug #2 from 400' to surface (35 sks.). Cut casing off 4' below ground level in order to set underground marker plate. Completed plugging.
