Dear Mr. McMillan:

New Mexico Oil Conservation Order R-8952 (for the protection of migratory birds) became effective June 15, 1989 and states that all pits and open tanks more than 16' in diameter shall be screened, netted or covered.

On July 12 and November 18, field inspections conducted by Denny Foust and Charles Gholson revealed that the above mentioned pits contained water with hydrocarbon skim. In order for these pits to be in compliance, you are hereby directed to remove all fluid or properly net these pits by December 22, 1993.
