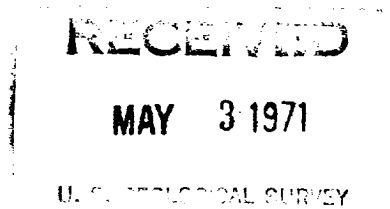

Well was temporarily abandoned 2-9-71. Plan to re-enter well and inject produced water from water pit into Dakota formation. Well contains 4 1/2" casing cemented from 881' up to 200'. Total depth is 909'. Plan to dispose of produced water into open hole portion of Dakota sand. Plan to commence work approximately May 31, 1971. Application to dispose of water being submitted to New Mexico Oil Conservation Commission under Rule 701-B.

Instructions
