3-1-95 TIH, tag sd @ 2945'. Load hole w/wtr. Attempt to PT csg, no test. TOO H. TIH w/ 2 7/8" tension pkr, isolate hole in csg @ 300'. TOO H. Establish circ through bradenhead. RU. Pump 160 sx Class "B" cmt w/2% calcium chloride. Circ 6 bbl cmt through bradenhead. Close bradenhead valve, sqz last 50 sx below hole. Displace w/0.75 bbl wtr. Sqz to 500 psi. SI. WOC. SDON.
