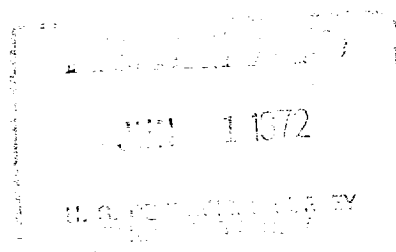

A 12-1/4" hole was spudded 5-25-72 and drilled to 230' where 9-5/8" casing was set at 224'. The casing was cemented with 200 sacks Class "A" cement with 2% CaCl₂. The cement circulated. The hole was reduced to 7-7/8" at 230' and drilling continued.

Instructions
