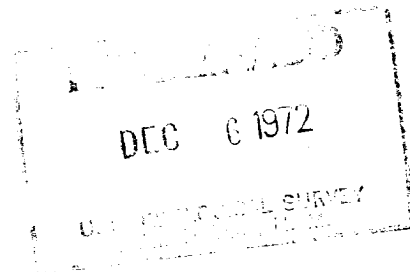

Spudded a 12-1/4" hole December 2, 1972, and drilled boulders 25' below surface. On December 3, 1972, the 8-5/8" casing was set at 227' with 200 sacks Class "A" cement with 2% CaCl2. The cement circulated. The hole was reduced to 7-7/8" at 229'.
