
Dear Emery:

Once again I must enlist your assistance, if I may.

I have filed the necessary communitization papers with the U.S.G. in Roswell covering the captioned lands. Mr. John Monroe called this morning to tell me everything was in order, except that he needed a Order from the N.M.O & G.C.C. approving the non-standard unit, which embraces the N $\frac{1}{2}$ of Sec. 30. It covers 328.50 acres. I sent along a plat showing the acreage content when I filed my communitization papers and hoped that this would suffice; but apparently it won't.

Therefore, at your early convenience will you please advise Mr. Monroe that your office has, or will approve the Dakota Unit, covering the N $\frac{1}{2}$ of Section 30, which contains the abovementioned 328.50 acres. You will recall that we had the same question arise on the S $\frac{1}{2}$ of Section 19. The U.S.G.S. approved the communitization agreement after you sent them your statement concerning the acreage content.
