3-25-73 T.D. 6650'. Landed tubing with bit and bit sub on bottom. Ran 216 Jts. 2-3/8" O.D. 4.7# J-55 8R EUE tubing set at 6630'. Installed well-head, circulated 11.0# mud from hole with water - well dead. Attempted to kick well off by injecting gas and soap chased with water - well dead. Released Arapahoe Rig #7 at 3:00 p.m. 3-24-73.

3-27-73 Moved in Malcolm Kitchens pulling unit. Swabbed well one hour, well kicked off. Flowed well one hour, making estimated 4.5 MMCF with 450 psi casing pressure. Shut well in.
