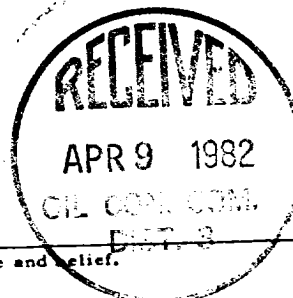

Plugged and abandoned on April 7, 1982 in the following manner:
Pumped water into the well and established a rate.
Mixed 11 sack plug and displaced it to 568' to 168'.
Let cement set for one hour.
Perforated 4 holes from 149 to 150'.
Established circulation with water.
Mixed cement and circulated until cement returned to surface. Used 20 sacks.
