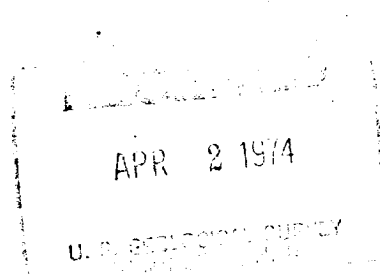

PBTD 2946'. Perf'd 2764-88' with 30 shots per zone. Frac'd with 24,000# 10/20 sand and 24,000 gallons treated water. No ball drops. Flushed with 1000 gallons water.
