Spudded well February 22, 1975. Drilled to 15', ran one joint 8-5/8" 24' casing, and set at 15' with 10 sacks cement.

Reached total depth of 926' February 27, 1975. Ran 29 joints 4-1/2" 10.5' casing, set at 895' with 50 sacks Class B and 50 sacks Pozmix A, circulated from T.D. to surface. Acidized open hole with 500 gallons 7% MCA acid.

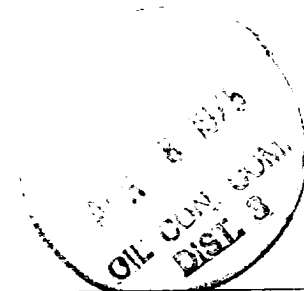
Plugged and abandoned with 50 sacks Class B cement from 926' to 678' and from 12' to surface March 5, 1975.

Cleaned location and set dry hole marker.

Instructions
